Ubica Gold Corp. ("<u>Ubica</u>") holds a 100% leasehold interest in certain mining claims and real property, located in Nevada, USA, near the Issuer's Tuscarora property and has previously entered into lease agreements (the "<u>Leases</u>") with certain parties with respect to Ubica's leasehold interests.

On September 15, 2021, the Issuer and its subsidiary, American Pacific Mining (US) Inc. (the "<u>Purchaser</u>") entered into a lease agreement (the "<u>Agreement</u>") with Ubica, whereby Ubica has assigned to the Purchaser its interests in the Leases and the Purchaser has agreed to acquire 77 claims at Tuscarora totalling 1,031 acres (the "<u>Assets</u>") from Ubica.

In exchange for the acquisition of the Assets and assignment of the Leases from Ubica, the Issuer has agreed to pay Ubica the following remuneration:

- a. CAD\$800,000 cash; and
- b. 3,700,000 common shares of the Issuer (the "<u>Shares</u>") at \$0.87 per Share. The Shares are subject to a 18 month contractual escrow, with 25% of the Shares being released on closing of the Transaction, and 25% being released every 6 months.
