On January 4th, the Issuer has published the results of exploration program on Augdome property that began on October 23rd. The drill program consisted of approximately 1,721 metres of core diamond drilling in 11 holes and confirmed gold-bearing zones within the Destor-Porcupine fault structure located adjacent to the Dome Mine.

On January 15th, the issuer announced that it has raised addition \$210,000.

On January 24th, the issuer announced plans to establish a new subsidiary corporation to develop a blockchain platform for mining industry information using a distributed ledger system for the transfer of data, documentation, and related information. In addition, the issuer announced its intention to raise additional funds for the project use.

2. Provide a general overview and discussion of the activities of management.

The Issuer's primary management focus is on exploration and development of its gold properties located in the Timmins Gold District including the Augdome Property which hosts gold mineralized zones located adjacent to the Dome Mine operated by Goldcorp located in Central Timmins. Also located in Central Timmins is the TimGinn Property which hosts the former Gilles Lake Mine and is located adjacent to the Hollinger Mine operated by Goldcorp. In East Timmins is the Blue Quartz Property which hosts the former Blue Quartz Mine located 10 km north of the Black Fox Mine operated by Primero Mining.

The results of October-December 2017 exploration program were published. An intention to establish new subsidiary with technological focus was announced (subject to shareholder approval).

McLaren Resources Inc. ("McLaren" or the "Company") announced that it has increased the non-brokered private placement financing previously announced on January 2, 2018 from \$350,000 to \$565,000. The increased financing consists of common share units for gross proceeds of \$215,000.

With respect to the increased financing, the Company has issued a total of 2,150,000 common share units at a price of \$0.10 per unit. Each common share unit consists of one common share and one common share purchase warrant which entitles the holder to purchase one common share in the capital of the Company at an exercise price of \$0.15 per share for a period of 18 months from the date of issuance.

In connection with the increased financing, McLaren paid finder's fees consisting of \$11,650 in cash and \$2,000 by way of issuance of 20,000 common shares at a value of \$0.10 per share to qualified registrants.
